**Section SC-1.0 SCOPE OF WORK:**

In addition to the general explanation regarding the estimated quantity of work, the enclosed maps offer a perspective of the SAWS water distribution system workload on a given day. Much of this work is completed by in-house crews with some portion intended to be completed through this contract.

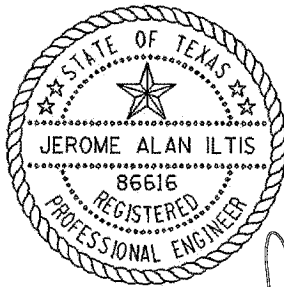
**Section SC-2.4 PERFORMANCE TIME:**

The requirements of Section SC-2.4 PERFORMANCE TIME do not apply to work orders that involve leak repairs on water main pipe greater than 16 inches in diameter or work orders that involve replacing existing valves larger than 16 inches. The performance time requirements for work orders involving these larger assets will be negotiated separately at the time the work order is issued.

**Remove Paragraph Four (4) from Invitation to Bidders, Page IV-1 and Replace with the Following:**

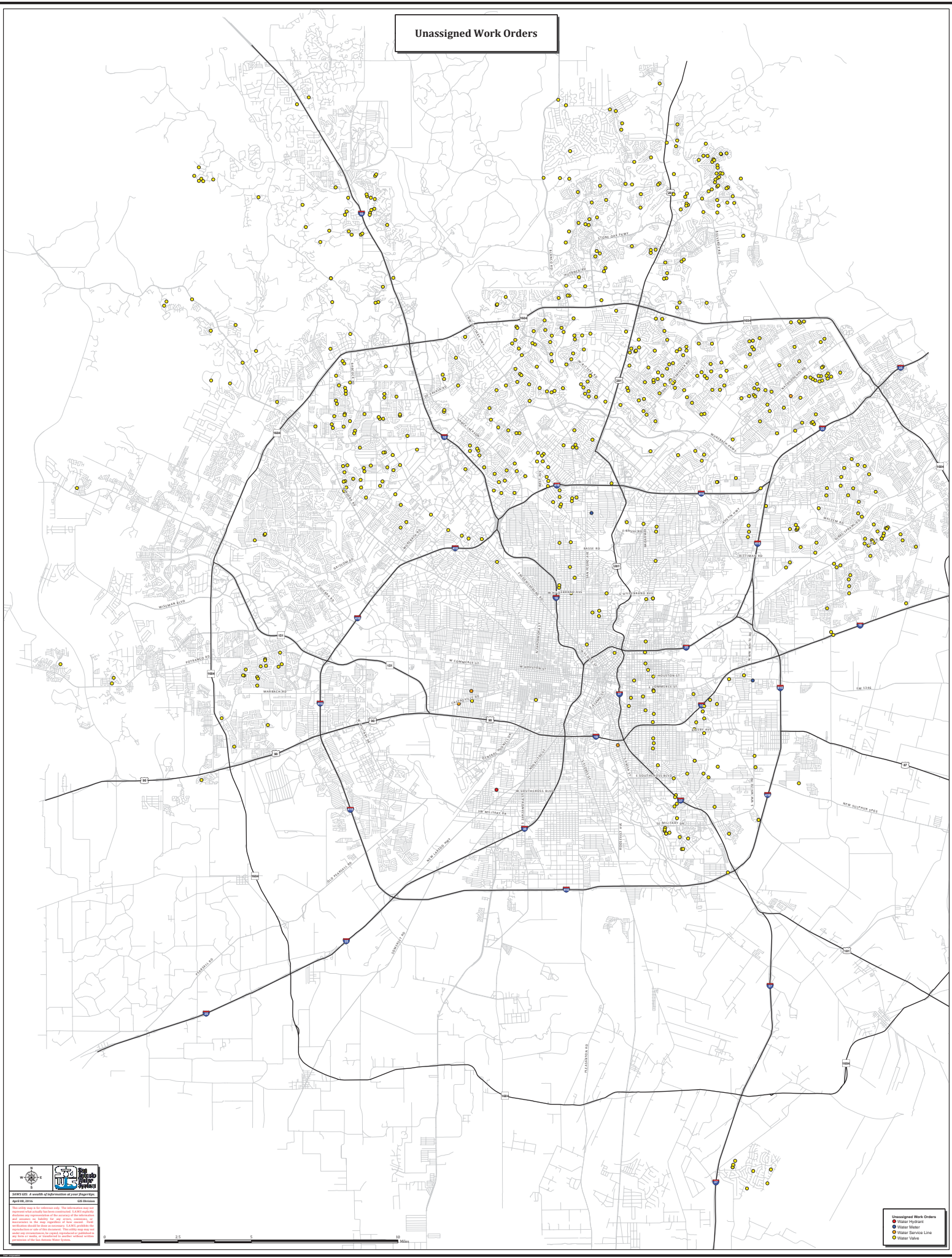

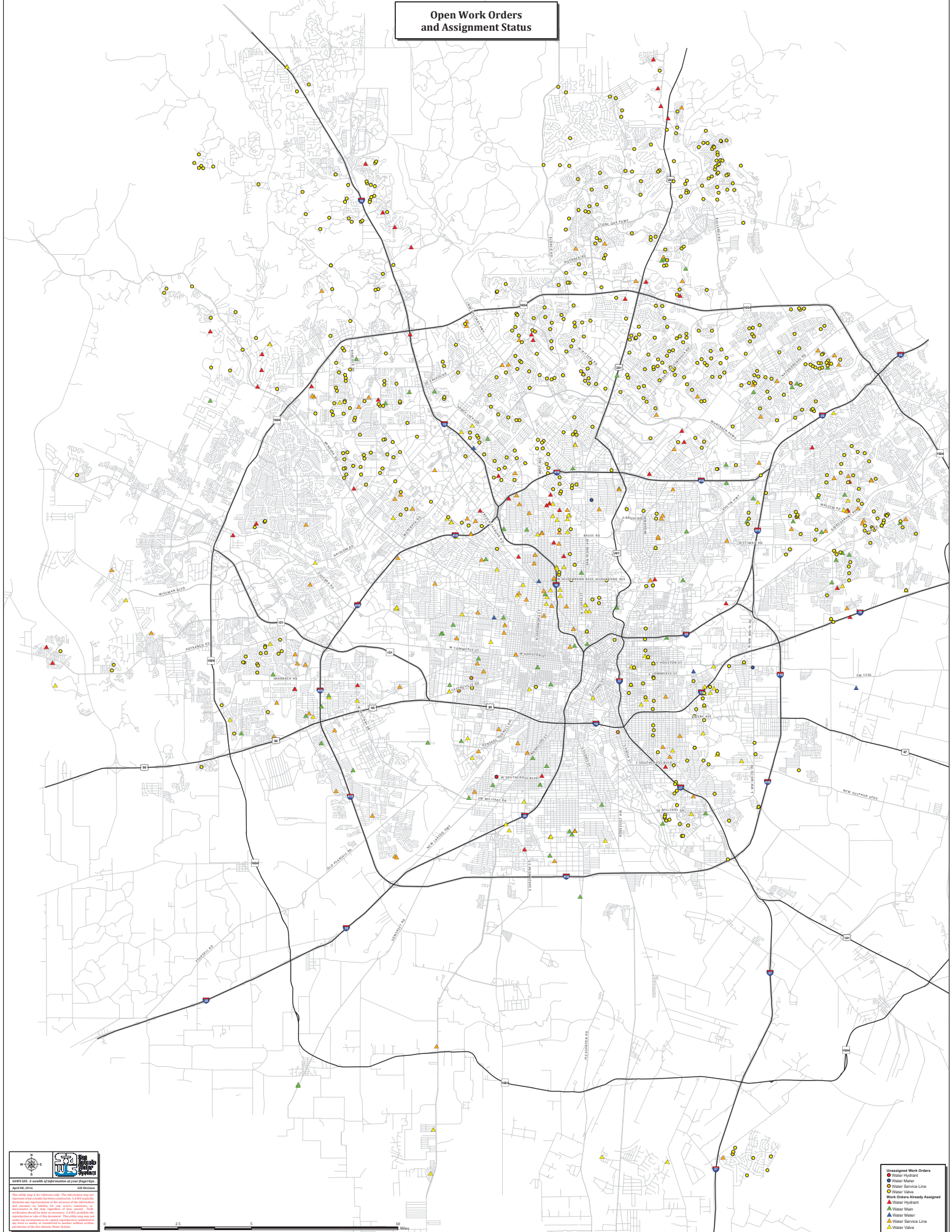
