A: No, but we ask prime contractors to do their best with good faith outreach efforts. If the goal is not met, proof of outreach efforts is required with the submittal.

• Q:What if I am having trouble finding SMWB subcontractors?

A: Please email the SMWVB Program Manager with the scopes of work you are seeking. You will receive lists of local SMWVB-certified firms to contact.

- Q:What if my business is SMWB-certified? Do I need to find SMWB subs?
   A: If your firm is SMVVB-certified, you will most likely meet the goal. However, the GFEP is a required document, and a good faith outreach effort is still necessary.
- Q: Do I need to include all my subcontractors in the GFEP or just those that qualify towards the SMWB goal?

A: All subcontractors need to be included in the GFEP, even those that may not count towards the SMWB goal.



# **Bid Packet Preparation**

- Utilize the Bid Packet Checklist within the specifications
- Statement of Bidder's Experience be completed and included by all Bidders
- Company information packet, statement regarding ability to complete the project, and W-9 also to be included by all Bidders
- Double check all mathematical calculations and verify all extensions
- Addendums are now acknowledged on the Bid Proposals
- Ensure Mob and Prep of ROW do not exceed the percentage

# Statement of Bidder's Experience

- Statement of Bidders Experience form required for this project
- Bidder should use the checkboxes to confirm that the similar projects meets the requirements
- Requirements vary for all 3 projects

- Point of contact should be the Owner (not the design engineer)
- Work performed should be done by the contractor as the prime (not as a sub)
- Reference contact information should be verified prior to submitting

### **Contract Requirements**

Prevailing Wage Rate and Labor Standards – Section 2.10 of the General Conditions

- Certified payroll to be submitted on weekly basis
- Wage decisions are included within the specifications
- Contractors to utilize LCP Tracker
- Site visits are random and unannounced
- Interviews will be Conducted and will be private & confidential
- Payroll records are subject to review
- All apprenticeship programs will need to be approved by Department of Labor prior to starting
- Contractors are responsible for sub-contractor payroll
- Late payrolls delay contractor payments from SAWS



### **Contract Requirements**

- Insurance requirements are found in Section 5.7 of the GCs
  - Builder's Risk is replaced by Installation Floater coverage (see Supplemental Conditions)
  - Maintain insurance coverage during the construction of this Project
- Compliant prior to executing the contract
- Will ask for insurance prior to Board award to expedite execution of the contract
  - Any deficiencies must be corrected prior to Board award



# Contract Background

### **Special Conditions**

- Contractor to submit a completion report when the project is complete
  - Pre and post MPEG-1 video and video logs
  - Any tests and/or submittals specified in the Contract Documents
- Payment
  - The unit price cost for items shall include all the necessary incidental work as subsidiary to the item unless otherwise specifically called out in the plans or approved by SAWS

### **Contract Requirements**

Supplemental Conditions - Continued

- Worksite
  - No excavation work of any kind may begin until authorized by SAWS
  - Preliminary work such as televising, utility investigation/potholing, setup and testing of bypass pumping may not begin until approval in writing by SAWS
- Consent Decree Notice Provisions
  - Retention of documents
  - Notification of events that may cause delay
  - Liability for stipulated penalties

- Item 515 Topsoil, 516 Sodding, and 520 Hydromulching

   incidental to other bid items in the contract and will not be paid for separately.
- Item 540 Stormwater Pollution Prevention Plan
  - Refer to Tobin Park 8-inch Siphon CIPP Contract Document for specific requirements
  - Measurement and Payment shall be made per Lump Sum
- Item 901 Rehabilitation of Sanitary Sewer by Cured-in-Place-Pipe (Hot Water or Steam Cured)
  - Shall be water inversion where the lining is inverted under pressure of water and cured by circulating hot water



# Contract Requirements

### Special Provisions to Special Specifications

- Tree protection shall be in accordance to CoSA Special Specifications Item 801 Tree and Landscape Protection and 802 Tree Pruning, Soil Amending and Fertilization
  - Shall not be measured or paid for directly but shall be included in the unit price for the items in which the work occurs.

### Contract Requirements Permits and Other

- Tree permits has been obtained for Carelin Drive and Tobin Park
- Floodplain permit is required for Tobin Park and has been obtained
- Contractor shall coordinate with CoSA Parks and Recreation Department (PARD) prior to utilizing Tobin Park access gate
  - Gate is to be closed position at all times




# Project Requirements

### **Project Details Continued**

- Contractor will be responsible for restoring vegetation within Tobin Park and existing sewer easement at Carelin Drive
- Carelin Drive Access to alley from existing 16' Sewer, Water, Gas, & Electric Easement
  - Contractor to avoid impacts to established trees within 16' easement. Contractor to coordinate with SAWS inspector and property owners prior to mobilizing. If required for access, temporary removal of fence and gate shall be coordinated with SAWS and property owner. Removal and reinstallation of gate/fence will be a no separate pay item.
  - Protect trees in accordance to CoSA Special Specification 801 and Tree Preservation General Notes & Details within construction plans
  - Alternative access to alley from Carelin Drive right-of-way across from Crippen Avenue between 5122 Careline Drive and 5151 Sherri Ann Road property.
