# Good Faith Effort Plan (GFEP) FAQs

• Q: Is the 20% SMWB goal mandatory?

A: No, but we ask prime contractors to do their best with good faith outreach efforts. If the goal is not met, proof of outreach efforts is required with the submittal.

- Q:What if I am having trouble finding SMWB subcontractors?
  - A: Please email the SMWVB Program Manager with the scopes of work you are seeking. You will receive lists of local SMWVB-certified firms to contact.
- Q:What if my business is SMWB-certified? Do I need to find SMWB subs?
   A: If your firm is SMVVB-certified, you will most likely meet the goal. However, the GFEP is a required document, and a good faith outreach effort is still necessary.
- Q: Do I need to include all my subcontractors in the GFEP or just those that qualify towards the SMWB goal?

A: All subcontractors need to be included in the GFEP, even those that may not count towards the SMWB goal.



#### **Bid Packet Preparation**

- Utilize the Bid Packet Checklist within the specifications
- Double check all mathematical calculations and verify all extensions
- Addendums are now acknowledged on the Bid Proposals
- Ensure Mob and Prep of ROW do not exceed the percentage
- References and contact information must be verified prior to submitting bid(s)

#### **Contract Requirements**

Prevailing Wage Rate and Labor Standards – Section 2.10 of the General Conditions


- Certified payroll to be submitted on weekly basis
- Wage decisions are included within the specifications
- Contractors to utilize LCP Tracker
- Site visits are random and unannounced
- Interviews will be Conducted and will be private & confidential
- Payroll records are subject to review
- All apprenticeship programs will need to be approved by Department of Labor prior to starting
- Contractors are responsible for sub-contractor payroll
- Late payrolls delay contractor payments from SAWS

#### **Contract Requirements**

- Insurance requirements are found in Section 5.7 of the GCs
  - Builder's Risk is replaced by Installation Floater coverage (see Supplemental Conditions)
  - Maintain insurance coverage during the construction of this Project
- Compliant prior to executing the contract
- Will ask for insurance prior to Board award to expedite execution of the contract
  - Any deficiencies must be corrected prior to Board award



  - approximately 222 LF of 10" sanitary sewer main (CIPP)



#### **Special Conditions**

- Contractor to submit a completion report when the project is complete
  - Pre and post MPEG-1 video and video logs
  - Any tests and/or submittals specified in the Contract Documents
- Payment
  - The unit price cost for items shall include all the necessary incidental work as subsidiary to the item unless otherwise specifically called out in the plans or approved by SAWS

#### **Contract Requirements**

Supplemental Conditions - Continued

- Worksite
  - No excavation work of any kind may begin until authorized by SAWS
  - Preliminary work such as televising, utility investigation/potholing, setup and testing of bypass pumping may not begin until approval in writing by SAWS
- Consent Decree Notice Provisions
  - Retention of documents
  - Notification of events that may cause delay
  - Liability for stipulated penalties

### **Contract Requirements**

#### Supplemental Conditions

- Contractor shall perform the Work with its own organization on at least 40% of the total original contract price.
- Liquidated damages will be assessed as follows for final completion extending beyond contract time of all Project Phases:

- Item 900
  - Paving restoration for entry/launch pits subsidiary to pay item
- Item 901
  - Water inversion/hot water curing
- Item 1103
  - For use when excavation is very near existing AC water facilities
  - Two methods clamp and pipe replacement

#### Project Requirements

- City of San Antonio right-of-way permit

  - Contractor responsible for traffic control plans for COSA segments unless included in plans.

#### Permits and Other

- Bypass Piping
- Conceptual layouts provided for TxDOT related segments only
  - Contractor responsible for bypass submittals for all segments.
  - Project Locations 2, 8, 11, 12 at upstream ends of line and need no bypass
  - Contractor responsible for maintaining access through intersections and driveways. Use of buried piping and hose/road ramps as indicated in the plans (incidental to the bypass pumping line item)
- Project Location 2 numerous parallel utilities; hand digging may be required
- Project Location 3 mix of pipebursting and CIPP




