- **3.** Supplemental Conditions: Instruction to Bidders item 24(b) shall be changed to "A Detailed Baseline Schedule based on NTP of July 20, 2020."
- **4.** Specification 43 23 31.35, Deep Set Vertical Turbine Pump: Impeller material as specified in paragraph 2.5 item 2 and 2.5.2.a shall be changed to "nickel-aluminum-bronze", and bowl bearing as specified in paragraph 2.5 item 3 shall be changed to "bronze".
- 5. Specification 43 23 31.35, Deep Set Vertical Turbine Pump: Warranty period as stated in paragraph 1.8 shall be changed to "two (2) years" to be consistent with requirement in General Conditions.
- 5. Specification 43 42 22, Welded Steel Bladder Surge Arrestor Tank: Warranty period as stated in paragraph 1.8 shall be changed to "two (2) years" to be consistent with requirement in General Conditions.
