- 2. INVITATION TO BIDDERS.** The second sentence of the seventh paragraph is hereby modified to read as follows:
“Bids will be received either Electronically or through Sealed bids, until **2:00 PM (CDT), October 22, 2021.**”
- 3. INVITATION TO BIDDERS.** The eight paragraph is hereby modified to read as follows:
