2. Invitation to Offerers, paragraphs 1, 4, and 5, are removed and replaced as follows:

Sealed bids for the purchase of LAND will be received by SAWS either Electronically or through Sealed bids, until 2:00 PM (CST) on January 26, 2024. December 15, 2023. Electronic bids will be received via a secure SAWS File Transfer Protocol (FTP) site. Sealed bids will be received by Contract Administration, 2800 U.S. Hwy 281 North, Tower II, Customer Center Building, via a drop box located on the left wall when walking through the first set of double glass doors of the main Tower II entry on the north side of the building, San Antonio, Texas 78212. No requests for FTP site access will be accepted after **2:00 pm (CST) on January 25, 2024.** December **14, 2023.** Once a Bidder is approved for access, an email with a hyperlink to the FTP site and a unique password for the Bidder will be provided to the Bidder's email recipient.

Once access is received, Bidders may upload the required documents per the Purchase Agreement any time before **2:00 pm (CST) on January 26, 2024, December 15, 2023,** Please ensure to allow sufficient time should Bidder's experience technical difficulties in uploading the required documents. No changes to the Bid nor bid price can be made once the Bid has been submitted.
