- 1. Can SAWS provide a map of the proposed project location, well sites, and anticipated routing for the collection line and access roads?
 - A map is being provided as supplemental information which shows the project location, SAWS property including the Twin Oaks Water Treatment Plant, and the well sites. Pipeline routing is part of the scope and has not been determined at this time.
- 2. If a map is not available, does SAWS have an estimated length and approximate diameter for the collection line?
 - This will be determined during the design phase.
- 3. Can SAWS provide the estimated well sizes?
 - Wells are planned to be approximately 18" diameter.
- 4. Will disinfection be required at the well heads?
 - Disinfection will be required at the well heads.
- 5. Does SAWS anticipate any water storage or intermediate booster pump stations being required?
 - No water storage or pump stations are anticipated for this project.
- 6. Could you clarify if 11 x 17 pages will or will not count toward the page limit? Refer to Page 8, Item #7.

- 7. If we use an 11x17 for the org. chart, will that count as 2 pages or 1 page?

- 8. Do we also need to include these items from our sub-consultants on the team:
 - a. W-9 Form
 - b. Past Performance List of SAWS projects
 - c. Team Experience List of at least 3 current/previous projects Past 5 years of Similar Services Projects
 - d. Proof of Insurance
 - e. Conflict of Interest Questionnaire
 - None of these items are required to be submitted from proposed sub-consultants. See Section IV, C. Response Format.
- 9. Are designers engaged on the original Carrizo Project prohibited from being sub consultants to a team?

- 10. The scope includes preparation of Environmental Constraints Analysis, initial THC coordination, and submittal of USACOE 404 Nationwide Permit documents. Should we assume that additional detailed environmental studies that may be required for the USACOE permit documentation, such as archaeological surveys, historic resources evaluations, on-site jurisdictional waters delineations, and threatened/endangered species surveys, should also be included as part of the scope?
