ADDENDUM 1 August 26, 2022

To Bidder of Record:

This addendum, applicable to work referenced above, is an amendment to the bid proposal, plans and specifications and as such will be a part of and included in the Contract Documents. Acknowledge receipt of this addendum by entering the Addendum number and issue date on the space provided in submitted copies of the bid proposal.

RESPONSES TO QUESTIONS

1. Question: Can we get the AutoCAD file for this project?

Response: The AutoCAD file is not available at this time. It will be released to the selected bidder.

2. Question: Can the bid date be rescheduled to a later date in the week due to the Labor Day holiday? Possibly the 8th or 9th?

Response: The bid date cannot be rescheduled and will remain September 6, 2022.

3. Question: According to specification 804, the required compaction for the secondary backfill in paved areas is 98%. Since the sewer pipe is being installed in unpaved areas, will a 90% compaction of the secondary backfill be acceptable?

Response: A minimum compaction of 98% will be required within the secondary backfill zone.

4. Question: Will the tunnel boring require backfill annular grouting between the carrier pipe and the casing? And can you add a bid item if it is required.

Response: Per Specification 856.7, the price per linear foot of pipe jacking shall include full compensation for all materials (casing spaces, grout, labor, tools, equipment and incidentals) necessary to complete the work.

5. Question: We feel that with the amount of bores and the majority of open cut being too deep, there is not enough days to complete this work. Can you add additional days for this work.

Response: Recently completed projects of similar scopes, coordination with suppliers, and contractors have indicated that the proposed number of days to complete the work is adequate.

6. Question: Since Geotech shows groundwater, can a bid item be added for groundwater control?

Response: Per Supplemental Specification 2140, control of ground and surface water is considered

subsidiary to the work and no separate payment will be made for the work.

7. Question: Will bypass be needed at the tie-in?

Response: A bypass will not be required since there are no existing upstream flows.

8. Question: Are the 5' Diameter Manholes to be 5' in diameter all the way to finished elevation or at

a CenterPoint be reduced to 48" Diameter?

Response: The manholes should conform with SAWS Detail DD-852-11.

CHANGES TO THE SPECIFICATIONS

- 1. Update Supplemental Conditions, Article VIII. Contract Completion Time, Liquidated Damages:
 - Liquidated Damages, for the purpose of this contract, will be assess at \$1,037.00 per day.
- 2. Due to updates in the General Wage Decisions for Building Construction Type, remove the wage decision documents form the solicitation in entirety and replace with the revised version attached (rev. 08/05/2022 for General Decision Number TX20220231). This version should be utilized by the awarded contractor for this project.

Note: Executive Order (EO) 13706, Establishing Paid Sick Leave for Federal Contractors applies to all contracts subject to the Davis-Bacon Act for which the contract is awarded (and any solicitation was issued) on or after January 1, 2017. If this contract is covered by the EO, the contractor must provide employees with 1 hour of paid sick leave for every 30 hours they work, up to 56 hours of paid sick leave each year. Unlisted classifications needed for work not included within the scope of the classifications listed may be added after award only as provided in the labor standards contract clauses (29CFR 5.5 (a) (1) (ii)).

The body of each wage determination lists the classification and wage rates that have been found to be prevailing for the cited type(s) of construction in the area covered by the wage determination. The classifications are listed in alphabetical order of ""identifiers"" that indicate whether the particular rate is a union rate (current union negotiated rate for local), a survey rate (weighted average rate) or a union average rate (weighted union average rate).

Union Rate Identifiers

A four letter classification abbreviation identifier enclosed in dotted lines beginning with characters other than ""SU"" or ""UAVG"" denotes that the union classification and rate were prevailing for that classification in the survey. Example: PLUM0198-005 07/01/2014. PLUM is an abbreviation identifier of the union which prevailed in the survey for this classification, which in this example would be Plumbers. 0198 indicates the local union number or district council number where applicable, i.e., Plumbers Local 0198. The next number, 005 in the example, is an internal number used in processing the wage determination. 07/01/2014 is the effective date of the most current negotiated rate, which in this example is July 1, 2014.

Union prevailing wage rates are updated to reflect all rate changes in the collective bargaining agreement (CBA) governing this classification and rate.

Survey Rate Identifiers

Classifications listed under the ""SU"" identifier indicate that

no one rate prevailed for this classification in the survey and the published rate is derived by computing a weighted average rate based on all the rates reported in the survey for that classification. As this weighted average rate includes all rates reported in the survey, it may include both union and non-union rates. Example: SULA2012-007 5/13/2014. SU indicates the rates are survey rates based on a weighted average calculation of rates and are not majority rates. LA indicates the State of Louisiana. 2012 is the year of survey on which these classifications and rates are based. The next number, 007 in the example, is an internal number used in producing the wage determination. 5/13/2014 indicates the survey completion date for the classifications and rates under that identifier.

Survey wage rates are not updated and remain in effect until a new survey is conducted.

Union Average Rate Identifiers

Classification(s) listed under the UAVG identifier indicate that no single majority rate prevailed for those classifications; however, 100% of the data reported for the classifications was union data. EXAMPLE: UAVG-OH-0010 08/29/2014. UAVG indicates that the rate is a weighted union average rate. OH indicates the state. The next number, 0010 in the example, is an internal number used in producing the wage determination. 08/29/2014 indicates the survey completion date for the classifications and rates under that identifier.

A UAVG rate will be updated once a year, usually in January of each year, to reflect a weighted average of the current negotiated/CBA rate of the union locals from which the rate is based.

WAGE DETERMINATION APPEALS PROCESS

- 1.) Has there been an initial decision in the matter? This can be:
- * an existing published wage determination
- * a survey underlying a wage determination
- st a Wage and Hour Division letter setting forth a position on
 - a wage determination matter
- * a conformance (additional classification and rate) ruling

On survey related matters, initial contact, including requests for summaries of surveys, should be with the Wage and Hour National Office because National Office has responsibility for the Davis-Bacon survey program. If the response from this initial contact is not satisfactory, then the process described in 2.) and 3.) should be followed.

With regard to any other matter not yet ripe for the formal process described here, initial contact should be with the Branch of Construction Wage Determinations. Write to:
