### **RESPONSES TO QUESTIONS**

1. Question: Is there a CAD file available?

Response: To access the CAD file, Bidders must complete the Disclaimer form found on the SAWS website at the following link, also attached to this Addendum:

The CAD file is provided for informational purposes only and is not included as part of the Contract Documents.

2. Question: Will a geotechnical report be available?

Response: There is no geotechnical report available for this project.

3. Question: Can a bid item be added for extra depth manhole?

Response: Per SAWS specification 853.6, FRP manholes are measured in their entirety, including depths greater than 6 feet. No bid item will be added for manhole extra depth.

4. Question: Can you add a bid item for traffic control?

Response: See #1, Changes to the Specifications. A line item has been added for traffic control.

5. Question: Is the RV near Sta 71+00 is in working condition so that it can be temporarily relocated?

Response: The travel trailer near Sta 71+00 has a hitch to aid in temporary relocation.

6. Question: Is there bypass needed for the connection to the existing manhole?

Response: No, there is no upstream flow at the existing manhole this project is connecting to. As such, no bypass is necessary.

7. Question: For the jack and bore portion of the job, will contact and annular grouting be required? There is no detail shown in the plans.

Response: Contractor to refer to SAWS Standard Detail DD-856-03 for installation of sewer pipe in casing.

8. Question: Who will be providing inspection services on the project?

Response: SAWS will be providing inspection services for this project. An inspector will be assigned as a point of contact for the contractor.

### **CHANGES TO THE SPECIFICATIONS**

1. Remove the Bid Proposal in its entirety and replace with the attached revised Bid Proposal. Line item 21 has been added. Bidders shall use the revised bid proposal when submitting a bid for this project. Failure to use the revised version may result in the bid being found non-responsive.
