CHANGES TO THE SPECIFICATIONS

1. **REQUEST FOR COMPETITIVE SEALED PROPOSALS.** The second sentence of the seventh paragraph is hereby modified to read as follows:

"Proposals will be received electronically only, until 2:00 PM (CDT), July 8, 2021."

2. REQUEST FOR COMPETITIVE SEALED PROPOSALS. The last paragraph is hereby modified to read as follows:

"Respondents will need to submit a request by July 7, 2021 at 2:00 PM (CDT) to receive access to the File Transfer Protocol (FTP) site via email to Janie.Powell@saws.org. Respondent's email requesting access to the FTP site shall provide the legal name of Respondent's company and the intended recipient's email address and phone number. No requests for FTP site access will be accepted after July 7, 2021 at 2:00 PM (CDT)."

3. ELECTRONIC PROPOSAL OPENING INSTRUCTIONS. The header and first two paragraphs are hereby modified to read as follows:

ELECTRONIC PROPOSAL OPENING INSRUCTIONS July 8, 2021 at 2:00 PM (CDT)

In order to receive **electronic proposals** for this RFCSP, SAWS will utilize a SAWS secured File Transfer Protocol (FTP) site. Only Respondents submitting as Prime Contractors will need to submit their request prior to **July 7**, **2021 by 2:00 pm (CDT)** to receive access to the FTP site via email to **Janie.Powell@saws.org**. Respondent's email shall provide the legal name of the Respondent's company and the intended recipient's email address and phone number. No requests for FTP site access will be accepted after **July 7**, **2021 by 2:00 pm (CDT)**. Once a Respondent is approved for access, an email with a hyperlink to the FTP site and a unique password for the Respondent will be provided to the Respondent's email recipient.

Once access is received, Respondents may upload the required documents per the revised Respondent's Proposal Checklist any time before July 8, 2021 at 2:00 PM (CDT). <u>Please ensure to</u> allow sufficient time should Respondents experience technical difficulties in uploading the required documents. No changes to the proposal price can be made once the proposal has been submitted."

RESPONSES TO QUESTIONS

1. Question: I have reviewed the plans and specifications for this project and found that SCI was not listed as an approved controls contractor for this phase. Please consider adding SCI to the approved control contractors list, SCI has programmers & control technicians on staff as well as a UL508A panel shop located at our main office in New Braunfels Texas.

Response: SCI will be added to the approved controls contractor list.

2. **Question:** I noticed in the 09902 section that it states "All painting materials shall be fully equal to those manufactured by the Tnemec Company Inc. or Sherwin-Williams Company." Does this also apply to the interior concrete linings portions of the project? Also does SAWs have an approved manufacturers list for the interior wet well concrete linings?

Response: Refer to the Contract Documents for schedule of manufacturers and suppliers for major equipment or products list regarding the interior concrete linings. The approved manufacturer's list is available upon request from SAWS.
