Question received for bid no. 20-0249 Flexible base Material

1. Can you help me get a better understanding of delivery site(s) for this contract? **Delivery Sites are SAWS operations centers where bulk materials are stockpiled in concrete material bins.**
2. Is there something I could reference to limit the travel expectations North and South? **Commerce St. is the reference street for north and south deliveries.**
3. Could I expect to stay within loop 1604, be it North or South of Commerce? **Yes, you can expect to stay within Loop 1604, delivery sites are located within Loop 1604.**
4. Is there a mileage limit one way or the other? **Mileage limits should be the responsibility of the carrier.**
5. In the bid packet it states that the base material must come from a quarry within Bexar County. Can the base materials come for a quarry in the surrounding area County? **The reason we want the base material to come from a quarry within Bexar County is because in the event of an emergency we do not want to send our dump trucks outside the county to pick up the material.**
