SAWS Tapped for Leading Utilities of the World

San Antonio Water System is now the only utility in Texas — and one of a handful in the nation — to join the ranks of the Leading Utilities of the World, an exclusive global network of water and wastewater utilities

Members of the LUOW represent the gold standard of utility

innovation and performance throughout the developed world's water sector and include representatives from Denmark, Norway, Scotland, The Netherlands, Budapest, Japan, Australia and Singapore. In the United States, members include Los Angeles, Atlanta, New York — and now San Antonio.

"This honor says a lot about the hard work and dedication of our employees and the leadership of the Board of Trustees," said Robert R. Puente, SAWS President/CEO, who accepted the honor at the induction ceremony during the American Water Summit in Austin, Nov. 30.

"The application and interview process were challenging, but it was well worth it to join this extraordinary group," said Puente. "The sharing of information with these other top-performing utilities will yield great benefits to our customers down the road."

LUOW inductees must be nominated by other gold-standard utilities and complete a rigorous interview and selection process. To be selected, a utility must demonstrate outstanding innovation in at least three areas of management and have an ambition to continue to drive performance in the years to come.



A rate adjustment approved by San Antonio City Council in December 2017 takes effect Jan. 1, 2018. The 2018 adjustment will change the average SAWS monthly bill from \$62.24 to \$65.69 — a difference of only \$3.45.

Council also approved a rate adjustment of 4.7 percent for 2019 that would change the average monthly bill from \$65.69 to \$68.63 — a difference of \$2.94.

That adjustment would take effect Jan. 1, 2019.

The tables on pages 2 and 3 show the new rates for each service and customer type. The impact on your own bill may be greater than or less than the average depending on your water use.

These new rates will be effective for consumption on or about Jan. 1, 2018, and on or about Jan. 1, 2019, as applicable. Rate Table Definitions

General Class: Includes commercial, industrial and apartment customers. Irrigation Class: Customers that use water for landscaping, either through a separate meter or through a pro-rated amount of monthly water use. New business service accounts that are installing an in-ground landscape irrigation system are required to install a separate landscape irrigation meter. Wholesale Class: Customers who have entered into contracts for wholesale water and/or sewer service with SAWS. Recycled Water Class: Customers that use recycled water produced by SAWS for non-potable applications through a separate recycled water meter. Seasonal Rates: Recycled water rates applied to all billings beginning on or about May 1 and ending after five complete billing months on or about Sept. 30 of each year. Standard Rates: Recycled water rates applied to all billings beginning on

or about Oct. 1 and ending after seven complete billing months on or about April 30 of each year. **Base Consumption:** 100 percent of average monthly consumption of prior year. **Inside City:** Rates charged for customers living inside City of San Antonio city limits. **Outside City:** Rates charged for customers living outside City of San Antonio city limits. **Winter Average Consumption:** The fee for sewer service is based on the average monthly consumption of water during three complete consecutive billing periods beginning on or after Nov. 15 of each year and ending on or after three full billing cycles in March. **Wastewater Customers of Other Cities:** A different rate may apply to customers being billed by SAWS for wastewater for other municipal bodies.

Dos Rios Celebrates 30 Years of Innovation

A place you have a close relationship with, but may not know well is celebrating its 30th anniversary. The SAWS Dos Rios Water Recycling Center has been receiving and treating wastewater from most of San Antonio for three decades.

Located on the city's South Side, Dos Rios replaced the Rilling Road sewage treatment plant in 1987. At the time, it was the largest municipal construction project ever completed in San Antonio and created a significant boost in flows for the Medina, San Antonio and Guadalupe rivers.

Today, Dos Rios remains a cornerstone of the city's sewage system and showcases SAWS' leadership in water management innovation:

- Largest direct recycled water system in the nation.
- First in the world to produce treated biogas for the natural gas market.
- First to accomplish the environmental "trifecta," reusing all three sewage treatment by-products: water, biosolids and methane gas.
- First in the world to produce renewable sources for water, methane and solar power from one plant.
- Environmental Protection Agency's best treatment plant in the U.S. in 2004.

Even the water along San Antonio's River Walk comes from Dos Rios, providing much of the famed river's flow all the way down to the Texas coast.
